Failure by applicant to pay invoices at maturity makes all subsequent invoices immediately due and payable irrespective of terms should Seller so elect and Seller may withhold all subsequent deliveries until the full amount due is settled. Acceptance by Seller of less than full payment due shall not be a waiver of any of its rights and no waiver by either party of any default shall be deemed a waiver of any subsequent default. Applicant further agrees that should it become necessary to place applicant's account for collection, applicant shall pay all costs thereof, including reasonable attorney's fees.

Applicant agrees to pay for all purchases of goods and/or services according to the terms of Seller. No terms or conditions of purchase orders different from the terms of Seller will become part of any sales agreement, purchase order, or other document unless specifically approved in writing by Seller.

Applicant hereby agrees to pay late payment charges of 1.25% per month or as allowed by law on all overdue accounts. All charges are payable according to the terms of Seller's invoices unless otherwise pre-arranged with Seller's credit department. Should it become necessary for Western Wood Structures, Inc. to file suit to enforce payment of any charges, applicant agrees hereby that such suit may be brought in the State of _____. At Seller's option Seller shall be entitled to court costs, attorney's fees and interest at the rate of 10% per annum on all amounts found to be due and payable. Applicant further agrees that, upon written request by Western Wood Structures, Inc. and as a condition to the continued extension of credit herein applied for, a guaranty concerning all indebtedness or liability incurred in the name of Applicant, executed by person or entities and in a form acceptable to Western Wood Structures, Inc., will be provided within the time specified in such request.
